
- Section 5.3 <u>Duties of Family Representatives</u>: Each Family Representative will diligently perform the following duties during his or her term of service:
 - Coordinate activities between the Organization and the branch.
 - Communicate regularly with members of the branch regarding activities of the Organization.
 - Attend all meetings convened by the Officers.
 - Conduct business of the Organization, including receiving and approving regular reports and minutes of prior meetings.
 - Advise the Officers regarding their duties.
 - Compile and submit at least annually current contact information for each member of the branch.
 - Regularly submit to the Organization updated genealogical information on all members of the branch, including an annual report of all known births, marriages, deaths, and other pertinent genealogical and historical information occurring within the branch during the previous year.

Family Rep Roadmap

- Start with yourself: ensure all pertinent family history and contact information has been submitted for inclusion in the BFO "Master Family Tree" and "Master Contact List" and is correct and current for yourself
- Next, do the same for your spouse(s), your children, your children's spouses, your grandchildren and their spouses
- Next, move to your siblings, their spouses and children (your nieces and nephews and their spouses), etc.
- Then move to your aunts/uncles, first cousins, and their spouses
- Continue to second cousins and more distant relatives and their spouses







Rules of the Road

- Always identify where you are: who and what you already know, and who and what you need to discover
- Work outward in ever-larger circles
- Record what you find
- Share/submit your information
- Update information regularly
- Recruit others to help you
- Delegate when necessary
