

MINUTES OF BELNAP FAMILY OFFICERS AND REPRESENTATIVES
TELECONFERENCE ON 22 January 2008

Teleconference began at 1:05 P.M. with President Florence Ilene Ward Conducting. Brent Belnap offered the invocation. Corrections were made to the 23 October 2007 minutes. Conference started at 1:05 P.M. instead of 1:35 P.M.

Wes has found out that the pavilion that we wanted, the Gaslight pavilion, will be torn down to make room for a ride. The Wasatch Pavilion has been reserved and confirmed for the Belnap Reunion. It is in the north/east corner of Lagoon, no stage; but has a Public address system and will hold about 300 people. Parking lot is close by, so it will be easy to bring items in for the reunion. We're on the waiting list for the Oak and Maple Pavilions. These pavilions are more centrally located. Information on Lagoon can be soon found on the Internet type in, lagoonpark.com.

Parking will be \$8.00 per car. Wes will check to see if members of the Sons of Pioneers get free parking.

Prices for 2008 Lagoon are listed below; these are a reduced price for the reunion:

1. 4-64 or 65+, ride passport & entrance \$28.73 + Tax
2. 65 and older free entrance \$00
3. 3 and younger ride pass & entrance \$23.35 + Tax
3 and younger entrance \$00 with, free merry-go-round, train,
Ferris wheel and Lagoon-a-Beach.

Check to see if your Stake Lagoon Day is August 9, prices may be cheaper. If it is your Stake Lagoon day you must still advise Belnap Officers and representatives, so we can order/pay for your lunch.

Registration can be done at our pavilion. Suggested donation is \$5 each or \$15 per family. A family member will always be at the pavilion, so it will be fairly safe to leave your belonging as you enjoy the park.

Lagoon has not come out with a 2008 menu or the price, but it will have about 13 menus to choose from this includes Ala Carte items. One of flyers coming out will have the menu items. The Belnap Family Organization will pay for the lunch if reservations are made on time by July 1, 2008. The Lunch will be served between 2:00PM & 3:00PM with program starting about 3:00 PM.

Brent is checking on Ryan Shupe, for the entertainment.

Wes said he would be dressed as Gilbert Belnap the “Law Man” and will be the author of a paper named “Gilbert the Law Man”. A handout will be given to all attendees. Wes will check and see if we can provide a paid list to Lagoon for use at the ticket windows, so family members could just pick up their tickets or we could have a representative sit at the entrance. Family members must be per registered in order to get a free meal by 1 July 2008.
