2. OPENING PRAYER: An opening prayer was offered by Kirk Belnap

3. 2018 FAMILY REUNION. Diana Schultz led a discussion on the 2018 family reunion

Flyer:

Brent Belnap would post our reunion flyer on Facebook, as well as distribute the flyer through email.

Set Up:

Julie was able to reserve church on Friday night from 6:00-9:00 for set up. Brent Belnap, Matt Purcell, & Kirk Belnap will begin set up Friday night. Brent Belnap, Matt Purcell, & Loanne Bartholomew will help set up Saturday morning beginning at 8:00 a.m. Both Kirk and Loanne will try to bring additional family members to help. Loanne said that possibly her daughters and granddaughters would be able to assist.

IT:

Julie Moselle will find out what IT equipment can be provided by the stake, i.e. projectors, microphones, screens, etc. Brent Belnap, Matt Purcell & Ashley Belnap has also offered to bring their own projectors. Note - Projectors need HDMI ports. Julie Moselle will also check to see if someone from the stake could be on stand by for IT issues. This will be done closer to the time of the reunion.

Registration:

We have Larry Julian, Mark Goodmansen, & John Wiser to help with registration. Pat Johnson & Matt Purcell will make sure we have our square account to take payments.

It was discussed that we would reach out to other family representatives who weren't present at the meeting to find people to be the **chorister**, and give the **opening & closing prayers & pledge of allegiance**. It was noted that we should plan diversity in the parts as far as age, gender & family lines, and try to include a variety. It was also discussed that we could reach out through Facebook & Instagram to get more volunteers to help. This would be done closer to the date of the reunion.

Entertainment:

Loanne Bartholomew has scheduled the band Bluegrass Thunder to play at the reunion. Loanne will find out when the band requires payment (\$150.00). She will also find out what their needs are as far as electricity.

Games:

Ashley Belnap will be in charge of the children's games. She said that she will have her family help her. Larry Julian will provide a "rocket" activity for the children. Julie Moselle will check into the possibility of a water slide at the stake center. Ashley questioned whether there would be shade trees.

Menu:

The menu was discussed and it was agreed that hamburgers, hot dogs, & chips, (with condiments including fry sauce) would be served. Also the possibility of corn on the cob. It was decided that we would serve ice cream bars for dessert. Julie Moselle mentioned that Smith's Food on 13th East near the church works with non-profits on their food pricing. Loanne will check to see if her daughter, Sherrie Tucker, can check into ice cream options, possibly through Smith's. It was also decided that at registration that tickets for the meal would be distributed when payment is received. This would help make sure people didn't by-pass registration as well as help to regulate the distribution of food. Julie Moselle will check to see what is available at the stake center as far as grills, etc.

Handouts & Sales Items:

It was agreed that we would discuss these items at a future Officer's Meeting, as it would be time-consuming.

Crier:

It was requested that updated information be sent to Don Hammon to be included in the crier. Diana Schultz will check with Don to see when the deadline would be to send him the information.
