## GILBERT BELNAP FAMILIES GENEALOGICAL ASSOCIATION D/B/A BELNAP FAMILY ORGANIZATION OFFICERS MEETING MINUTES OF AUGUST 9, 2020

A meeting of the Officers of Gilbert Belnap Families Genealogical Association, a Utah non-profit corporation d/b/a Belnap Family Organization (the "Organization"), was held on August 9, 2020. The meeting convened at 2:00 p.m., Mountain Time, via web and teleconference.

- **1. ROLL CALL**. The following Officers were present at the meeting: Kirk Belnap (President), Julie Moselle (1<sup>st</sup> Vice President), Brent Belnap (2<sup>nd</sup> Vice President), Steve Belnap (Treasurer), and Matt Purcell (Secretary).
- 2. OPENING PRAYER. An opening prayer was offered by Matt Purcell.
- **3. 2020 FAMILY REUNION RECAP**. Kirk Belnap led a discussion on the 2020 family reunion. The following points were raised and discussed:
  - This was the first virtual reunion of the Organization. The Officers considered it to be success considering the difficult circumstances of COVID-19.
  - 112 separate devices joined the Zoom meeting. Many of those devices had multiple participants.

- Matt Purcell will compile login information for all Organization accounts and circulate those credentials to the Organization officers.
- Julie Moselle will develop a proposed fundraising plan to share with the officers and family representatives.
- Matt Purcell will post a link to the electronic version of the Crier on Facebook and Instagram.
- 5. FAMILY REPRESENTATIVES DISCUSSION. Brent Belnap led a discussion on the need to engage with Family Representatives on a regular and consistent basis. Primarily, the Officers need to train the Family Representatives on their duties under the Organization's Bylaws. Our goal is to identify and maintain contact with as many of Gilbert Belnap's descendants as possible. The Family Representatives are critical in accomplishing that goal. The Officers discussed in detail their motivations and desires to
