Kirk Belnap will draft a letter to Gordon Belnap further specifying the terms of the gifts and express the Organization's sincere gratitude for Gordon's generosity.

- <u>William Brewster Descendancy</u>: Through DNA evidence, it was confirmed that Gilbert Belnap, through his mother Jane Richmond, was a direct descendant of William Brewster, a passenger on the Mayflower.
