BELNAP FAMILY REUNION HELD 27 JUNE 1970 AT HOOPER, UTAH, PARK

Registration began early - by 10:00 a.m. handled by Wendell T. Belnap. An invocation was given by Dr. Howard K. Belnap at 10:45 a.m. followed by an "early bird" drawing for door prizes, conducted by H. Austin Belnap. At 11:00 a.m. the workshop session was presented by Della A. Belnap and Richard D. Belnap. Della reported on the genealogy work that has been done since the last reunion. There is still a lot yet to be done and she made a plea for help for family members to do this temple work. The Family is presently paying Frank Smith \$4.00 per hour for research in England.

Maude B. Kimball, granddaughter, gave a very interesting sketch of Gilbert and Adaline Belnap during the first few years of their marriage, and of her father, Gilbert Rosel, their first child.

Helene Kerr Smith, Family Historian, could not be in attendance so her brother, Knight B. Kerr, reported on the historical information and also made a plea to the family members to please send their articles in to be kept in the Family files. Belnap, Gordon L. Belnap and Della A. Belnap, were honored and given a book of verse. The three oldest living grandchildren were then honored: Lettie Hammon Stoker, age 87; Henry Belnap, age 87; and John Belnap, age 87. Fern B. Fowers also attended.

The LaGrande H. Belnap Family of Hooper were next on the program. Kevin and Gregg Belnap sang "Billie Boy" with Kevin accompanying them on a ukelele. Then Kevin sang alone the song "Blowing in the Wind". A male quartet from the George Ellis Belnap family, namely Francis A. (Bud), LaGrande, Darwin and Linden, sang a fun song and "Sing Along".
