Bowet the elder, daughter of Adam Pervyng (otherwise called Adam Pacok in the said fines) the son of Joan sometime the wife of John Pacok and one of the sisters of the said Robert Pervyng. the younger, Maud Walker of Cokirmouth, one of the daughters of Alice atte Wode the daughter of Emma de Skaleby, Robert's second sister, and Thomas Qwytlokman, son of Margaret Pape, Alice's second daughter, are the kinsfolk and heirs of the said Robert Pervyng, the younger, and of full age; and that the manors are held of the king in chief by cornage; and (2) to an order to Robert Louther, 'chivaler,' late escheator, to make a partition of the manors into two equal parts, take the fealty of the said Maud and Thomas Qwhytlokman (whose homage the king for a certain fine paid in the hanaper had respited until a certain day now past) and to cause them to have full seisin of their pourparty; saving to Isabel late the wife of Robert Pervyng, knight, her reasonable dower of the said manors, and retaining the second pourparty, which belongs to Margaret, in the king's hand until further order -to take the fealty of Thomas Bowet and cause him and the said Margery (sic) to have full seisin of Margery's pourparty thus retained in the king's hand, as the king for 20s. paid in the hanaper has respited until the quinzaine of Easter next the homage due from Thomas by reason of his having issue by Margery.

Commitment to John Draper, the younger,—by mainprise of Westminster. John Draper, the elder, and William Foughler, both Gamelyngeye,—of the keeping of a messuage, 30 acres of land and 2½ acres of wood in Gamelyngeye, co. Cambridge, late of Edmund Avenel, which Robert Bealknap, who made forfeit to Richard II, held of the grant of J. late bishop of Lincoln, and which by reason of a judgment rendered against Robert in the late king's Parliament came to the late king's hands and are still in the king's hand; to hold the same from Easter last for as long as the premises shall remain in the king's hand, rendering 28s. yearly by equal portions at Easter and Michaelmas, maintaining the houses and buildings pertaining to the premises, and supporting all charges incumbent thereon; as William Yarker, esquire, to whom the premises were committed on 21 November 1 Henry IV, to hold the same from Michaelmas then last past for as long as they should remain in the king's hand at the said yearly farm [Calendar of Fine Rolls, 1399-1405, p. 23], has surrendered in the Chancery for cancellation the letters patent thus made for him, to the end that the said John Draper, the younger, may have the keeping.
