

GILBERT BECOMES A CITIZEN

Americans have prided themselves on being a nation of immigrants. These immigrants helped to build this country and enriched its society with diversity and culture. From the earliest years laws have been passed and guidelines have been developed to instruct prospective citizens on American history, values, rights, and responsibilities.

Citizenship was granted to those who proved to the court's satisfaction that they were of good moral character and who took an Oath of Allegiance to the Constitution. Included in the citizenship process are many immigrants who



had lived in the United States for decades without filing papers to become a citizen, including Gilbert Belnap. Gilbert Belnap, immigrated from Canada, whose parents were both born in New England and had settled in Canada many years before.

Gilbert was born 22 December 1821 in Hope Township, New Castle District, Durham County, Ontario, Canada. For the first twelve years of his life he remained in Canada with his parents, but in 1832 he was indentured to wheelwright and became the responsibility of his "master," William C. Moore. The following December 1832 his father died and in March 1833 his mother Jane Richmond Belnap passed away. Gilbert had a brief time to say goodbye to his parents before they died, but soon after their passing, Mr. Moore decided it would be better for his own financial situation to move to nearby New York State. Gilbert spent only a short time in New York during the year 1833 and 1834, but then escaped servitude following years of continued abuse by William Moore.

In 1834 Gilbert headed home in order to make connections with his siblings. The situation was dire in Canada, his eldest

brother held all the rights to his father's estate and the money did not provide enough financial stability for him or his younger brother. After a brief stay in Durham County, Ontario, Gilbert headed west, just him and his younger brother, Derlin Belnap. He made stops to ease his burdens, but remained in Canada. He stayed for a brief time with Martial B. Stone, where he worked and found a short and stable residence, before moving on. His next stop was to the Quaker Family of Joseph B. Sing,¹ there leaving his five year old brother under their care.

Gilbert was then sixteen years old and continued his residence in and around his home town in Canada. In 1837 Gilbert took part in the Rebellion of 1837, a border dispute with the United States and Canada. He fought on the side of the United States, as did many in the area where Gilbert was living, believing that the land they had settled should belong to the United States, as it had for decades been settled by emigrants from the United States. The Rebellion was quickly put down by Canadian and British forces and Gilbert was captured and imprisoned in Toronto jail. While many of the leaders of the rebellion were executed, or transported by ship for being traitors, the eighteen year old Gilbert was released from prison and escorted to the border of Canada and New York. At age 18, and from then on, Gilbert made the United States his home.


Gilbert never settled for long periods of time in any one place, but traveled to Ohio where he joined the Church of Jesus Christ of Latter-Day Saints (LDS) in 1842, then to Illinois, where he married in 1845, and to Nebraska and Iowa, where he gathered with the LDS Saints on their move west. In 1851 Gilbert made his final journey west to the Utah Territory where at age thirty, Gilbert made his permanent home.

Once in Utah he served in the capacity of Selectman, Assessor, County Sheriff among other positions, most requiring an oath sworn to the United States and that he did when he swore his allegiance in *open court*, 7 March 1855.

THE POUND KEEPER

The community position as poundkeeper dates from the middle ages. It was most often an appointed position by a local government with the official responsibility for the feeding and care of stray livestock such as domestic pigs, cattle, horses, sheep, and geese. This was common in colonial America and continued into the early 20th century as an appointed position.

After the settlement of Weber County in 1850, Weber County covered a large parcel of land, from the Wasatch Front to the Eastern Shore of the Great Salt Lake. It included a rugged and often hostile area. On 23 October 1852 the Laws of Utah,² and in Weber County were enacted that described the position of poundkeeper in each county. They described it as; An appointed position by the County and the poundmaster shall be qualified and give bond not exceeding \$500.00. The newly established pound keeper's job was to collect strays and notify the owner or try to locate the owner of any stray animals that were found. If the stray had damaged any personal property, such as a garden, orchard, or killed other animals, then the pound keepers had the responsibility to assess the damage and fine the owner. Any unclaimed livestock was sold off and all funds turned over the Perpetual Emigration Office. Gilbert Belnap and Lemuel Mallory were appointed³as the first Pound

Keepers of Weber County. Gilbert was later

elected as Weber County Pound Keeper in 1854.

TRELOAR-PASCOE LINE UPDATE


Tamesin Treloar was the mother in law of Ebenezer Belknap, Hannah Ayer, and a great grandmother of Jesse Belknap. She was born in the town of Wendron, in Cornwall, England, probably in Lezarea, the Treloar Family holdings. Tamesin was the daughter of John Treloar Johanna Pascoe and of Cornwall. Wendron, The following update on this line contains new information found probate and historical Wendron records ofand Cornwall as to the identity of Johanna Pascoe, once thought to be the daughter of John Pascoe.

Johanna Pascoe was baptized in the Wendron, Cornwall church 30 May 1615. She died about 1646 in Wendron. Johanna was the daughter of Allin Pascoe and Elizabeth Harry, who married 24 February 1611 in Wendron, Cornwall, England.⁴

Prior researchers identified her as the daughter of John Pascoe and Agnes Trelowath, but the will of Allen Pascoe specifically leaves a legacy to his granddaughters Thamasin and

Mary Trelower, the daughter of Johanna Pascoe Treloar.

The following is the will of Allen Pascoe of



Wendron, Cornwall, England.

The 3 day of January 1643

BELNAP FAMILY ORGANIZATION NEWS

Dear All:

We have an Ancestry.com autosomal DNA test match through Gilbert Belnap to my father, Gordon Leslie Belnap (now deceased), through a woman named Anna Hall, born 30 Apr 1762, baptized 16 May 1762, in Trumbull, Fairfield, Connecticut, to Eleazer Hall and Mary Lake; later married Edward Duncombe; died 18 Jun 1848 in Easton, Fairfield, Connecticut.

The DNA connection is 10 cM across 1 segment with a person identified as "M.H." who is a 5th cousin once removed to Gordon. (Because I am one generation further removed, this connection does not appear on my Ancestry.com DNA matches.)

The cM rate is statistically high enough to confirm it is within the realm of possible DNA relationship with Gordon within the 5th to 8thcousin range. ("M.H." and Gordon also connect with someone identified as "sterling rice" across 20cM. Unfortunately, this other connection has not uploaded an ancestral lineage chart to Ancestry.com against which to compare potential lineage connections.)

The descent of "M.H." from Anna Hall appears at first glance to be defensible. Based on the birthdates and level of DNA connection, Anna would appear to be a sister of Eunice Hall (1762-1849), wife of Jesse Belnap (1760-1854) and paternal grandmother of Gilbert Belnap.

In other words, through autosomal DNA testing, we might finally have made a breakthrough on the previously unknown (but still highly speculated lineage of Eunice Hall). However, there are several important documentation problems that remain before we can consider the parentage of Eunice Hall to be resolved:

For starters, Anna Hall is recorded in the Barbour Collection as having been born 30 Apr 1762 in Trumbull, Fairfield, Connecticut. Eunice Hall's birthdate, from Phillips Cemetery, North East, Erie, Pennsylvania records, is shown as 25 May 1762. That is a birthday gap between Anna and Eunice of only 3.5 weeks, which is impossible. (Eunice's death notice, which appeared in the Erie Observeron 7 Apr 1849, lists her age as 86 (meaning a 1762-1763 birth year). If Eunice Hall was, indeed, born on 25 May 1762, then she would have been within two months short of her 87th birthday. However, even if the death notice and cemetery record dates fit nicely, they were made many years after Eunice's actual birthdate and could very easily be off either direction by several years.) If—and this is still a big IF—Eunice Hall is, indeed, the sister of Anna Hall, then either (a): Anna's birth year is incorrect (not likely, based on the record source) or (b) Eunice's birth year is incorrect—which would be more likely, although there is no record yet found in CT, for which 18th Century births are pretty well documented, for any Eunice born in 1762.

(There is a birth record for another Eunice Hall, born 28 Apr 1763 in Waterbury, New Haven, Connecticut, to Nathaniel Hall and Margery, baptized 20 Nov 1763 in Wallingford, New Haven, Connecticut.)

Even if Anna and Eunice are indeed DNA/biological sisters, Don Hammon has persuasively documented an entirely different Eunice Hall as a daughter of the same Eleazer Hall and Mary Lake, who was born 4 Mar 1770 in Connecticut and who married Andrew Curtis. While it was not uncommon in colonial New England for parents to give a later-born child the same name as an earlier born child, that was done only in the event of the death of the earlier named child.

And what to make of Deborah Hall, born perhaps 16 Dec 1758 in Trumbull, Fairfield, Connecticut (but also not found in the Barbour Collection), and who married on 23 May 1779 Giles Gilbert, also an "artificer" in the American Revolution in Redding, Fairfield, Connecticut—less than one month after Eunice Hall and Jesse Belnap were married, also in Redding, on 28 Apr 1779 (and later renewed their marriage vows on 10 Sep 1779 in Redding)?

A family connection between Eunice and Deborah, who is yet another daughter of Eleazer Hall and Mary Lake, does seem likely.

So, what to make of this autosomal DNA connection between Anna Hall, daughter of Eleazar Hall and Mary Lake, and Gilbert Belnap's paternal grandmother Eunice Hall? Is Anna Hall (1762-1848) a sister to Eunice Hall (1762-1849)? If so, then what is Eunice's actual birthdate? Is it possible that Eunice was not really 16 (going on 17) but actually only 15 (going on 16, born a year later in 1763), when she married Jesse Belnap (who, himself, was only 18 at the time)? And how could there possibly be two "Eunice Hall" daughters alive at the same time in the same nuclear family?

Interested in your thoughts, ideas, comments, additions, corrections, etc. Meanwhile, it would be super helpful if we could get a few more living great grandchildren of Gilbert Belnap (the oldest remaining generation, but who are fading fast—perhaps less than 50 out of 590 great grandchildren are still living) from different branches of the family to take Ancestry.com autosomal DNA tests to see what other cM matches might show up. (Given the way that DNA combines and is passed from one generation to the next, it is entirely possible for Eunice Hall's genetic inheritance that was passed on to other great grandchildren of Gilbert could vary quite a bit from the segment that my father Gordon received. And the more matching segments we can find, the better.)

Brigham Young University (BYU) has named Jeff M. Simpson as the new managing director of BYU Broadcasting. Jeff descends through William James Belnap.

On July 1, 2021, Simpson will take charge of BYU's radio, television, and digital channels, including BYUtv. He replaced Elder Michael A. Dunn, who became a General Authority Seventy of The Church of Jesus Christ of Latter-day Saints in April of this year.

Simpson's previous service includes time as president and publisher of the Deseret News, chief operating officer of Deseret Book, and CEO of Bonneville International, and work at Walt Disney Pictures and Buena Vista Television.

Jeff and his wife, Karen, had previously been called as a mission president and companion for the Washington Yakima Mission, but he has accepted this assignment to lead BYU Broadcasting at the invitation of the First Presidency.

Gordon Belnap's Donation

As noted on our last conference call, I (Brent Belnap) am working with local counsel in UT, at my own expense as a gift to the BFO, regarding setting up a perpetual operating endowment fund from the expected initial donation to the BFO from my father, Gordon L. Belnap, of \$50,000 as an initial seed amount (plus approximately another \$60,000 as a death bequest).

The understanding that there was an initial \$50,000, to be followed by an insurance beneficiary bequest of two life insurance policies in your name with a paid-up value of approximately \$30,000 each, for a total anticipated donation to the Organization of approximately \$110,000. This donation will help ensure the long-term financial stability of the BFO for many decades to come.



Past President and BFO Benefactor Gordon Leslie Belnap

Gordon Leslie Belnap, past president of the BFO and one of its greatest benefactors, passed away at the age of 91. Gordon passed away at his home on June 11, 2021.

Gordon was born in the home of his parents Arias Guy and Mabel Harris Belnap in Ogden, Utah on 17 November 1929 and attended schools in Ogden City and graduated from Ogden High School in 1947. After High School he attended Weber College and served on a LDS Mission.

In 1952 Gordon was drafted into the Army and went to California, where he was assigned to photography school in San Luis Obispo. From there he was shipped to Japan and finally Korea, assigned to the 45th Infantry Division, 45th Signal Company. He was stationed in the central part of Korea, north of Chuncheon.

After his military service had ended, Gordon returned to Utah settling in Salt Lake City, graduating from the University of Utah in 1956 with a degree in Business Management.

After receiving his degree Gordon moved to California where he began his banking career with Bank of America in San Francisco, living in Walnut Creek and San Leandro, California. He later returned to Ogden and worked for Commercial Security Bank as Vice President of the Real Estate Department, remaining there for 18 years.

Gordon was an active member of The Church of Jesus Christ of Latter-day Saints serving in many church callings. He served an LDS Mission to Finland from 1949 to 1952 and with his wife, Sharon, served in the Ogden Utah Inner-City Mission from 2015 to 2018.

Gordon was very active in the community, supporting the Jr. Chamber of Commerce, Ogden Board of Realtors, Weber County Homebuilders, Member Weber County Welfare Board, Treasurer Weber County Democrats, campaign manager for Congressman K. Gunn McKay, President Ogden Lions Club, member of Lake Bonneville Council Boy Scouts and president of "All Faces West"

pioneer pageant, as well as the Belnap Family Organization.

Gordon retired from banking in 1974, then established the US Mortgage Company and Mortgage Computer Association, retiring after 40 years.

He was a licensed pilot, enjoyed motorcycling, snowmobiling, boating at Lake Powell, his cabin in Eden, Utah, an annual trip to Yellowstone, and his winter home in Mesquite, Nevada.

Gordon is survived by his wife, Sharon Fife Belnap; two sons from his marriage to Joy McArthur; Brian and Brent Belnap; ten grandchildren and four great-grandchildren.

Gordon blessed us with so many years of dedicated service to the Belnap Family Organization as President for two terms, 1962 to 1964 and again from 1970 to 1972. He was editor of the Belnap Family Crier from 1967 to 1980 and contributed many more years of service with his wife Joy, who selflessly served the Organization as Secretary and Treasurer, and they jointly gave have blessed us all immeasurably. He has contributed to the legacy of his great grandfather Gilbert Belnap setting up a continuing account to help fund the BFO well into the future.

Florence Ilene Ward, age 61, and a long time resident of the Rexburg area died 6 December 2019 at the Madison Memorial Hospital. She was born to Bruce and Edith Ward on April 16, 1958 in Idaho Falls

Maternal Ancestry of Sarah Jones Belknap⁶⁷


The successful pursuit of a female ancestral line is often difficult, few records supported the woman's role in society during the 17th through the 20th Century, but occasionally there are key findings, through birth records, death records and especially through probated wills, that can lead one to extend a welcomed mother's pedigree. Such was the case with locating the maternal ancestry of Sarah Jones, the wife of Samuel Belknap, a joiner and both early residents of Salem and Haverhill, Massachusetts. What we know of her father Robert Jones, sometimes hailed, and probably incorrectly named "Cornet" Robert Jones of Hingham, Massachusetts, and her husband Samuel Belknap far surpass that which we have known in the past of her life and that of her mother's family. Presented here are my recent discovery into the heritage of Sarah Jones, whose mother died shortly after her birth, probably in Caversham, England.

John Brooks Threlfall in his 1990 works: Fifty Great Migration Colonists to New England & Their Origins, had the key clue to Robert Jones' wife's identity. The marriage record in Caversham, England of Robert Jones was transcribed as follows:

On 30 April 1621 Robert Jones married in the parish church of St Peter, Margaret Garrarde.

Margaret's death, although we know must have taken place soon after Sarah's birth by 1635, during the four years period when there are no extant records for St. Peter's Church, Caversham and just prior to Robert marrying the widow Jane Curtis.

We know that Robert Jones was married at least three times, the first 21 April 1630 in Caversham, Oxford (now Berks) England and second to Mrs. Jane Curtis, a widow from Caversham, with at least three children and third, Elizabeth, who he probably married in Hingham, about 1660, when he was a man of 65 years old. It was Robert's marriage to his second wife, Mrs. Jane Curtis, that gives us the clue to his first wife's ancestry.

The success of locating Sarah Jones Belknap's maternal ancestry began with the location of the marriage bond between her father, Robert Jones, and Sarah's step mother, the *widow Jane Curtis*. As Threlfall wrote, Robert hailed from Caversham, Oxford, England, a basic suburb on

the right bank on the Thames, from Reading, Berkshire, England and it was there that the marriage of Robert Jones and what Threlfall shows as *Garrarde* took place. The second marriage took place 9 June 1636 in South Stoke, Oxford, England, under bond dated 3 July 1635 and signed by Robert Jones and Christopher Garford.

Let all men know by these presents that we, Robert Jones of Caversham in the County of Oxford, husbandman and Christopher Garford of the Parish of St Michael in the City of Oxford, Bookbinder, Are held and firmly bound to Giles Sweit, Doctor of Laws and Lord Archdeacon of the Archdeaconry of Oxford, the lawfully-appointed Principal Official in the sum of £100 of the good and lawful money of England, to be paid to the same Giles Sweit, or to his proven attorney, heirs, executors, administrators or assigns,

To make which payment well and faithfully, in full and in cash, we do bind ourselves and each

the other, our heirs, executors and administrators, firmly by these presents.

Sealed with our seals, dated the 3rd day of the month of July in the 11th year of the reign of our Lord Charles, by the grace of God King of England, Scotland, France and Ireland, Defender of the Faith, etc, and in the year of our Lord 1635.


...he The Condition of this obligation is such, that if hereafter there shall not appear any lawful lett or impediment by reason or pre contract; consanguinity [i.e., blood-relationship], affinity [i.e., relationship by marriage], or any other lawful means whatsoever, but that the above bounden Rob(er)t Jones, widower, and Jane Curtiss of Reading in the Archdeaconry of Berkshire), widow may lawfully solemnize matrimony together, and in the same afterward

Robert Jones Christopher Garford

Robert Jones used his brother in law Christopher Garford,⁸ a successful bookbinder, as his surety (guarantor) for his marriage to Mrs. Jane Curtis, securing the precise spelling of Sarah's mother's maiden name as Margaret Garford and not that of Margaret Garneford, or Garrardeas as Therefall surmised.

Additional records to prove the relationship between Christopher Garford and Margaret Garford Jones were uncovered in the historical records of Oxford and as Christopher's position as a Bookbinder. Christopher was placed in Oxford as an apprentice at age 14. The Indenture

1615 Apprenticeship paper of Christopher Garford

contained the name of Christopher's father, Osmund Garford, as well as his place of abode, Abingdon, Berkshire, England.


Osmund Garford's family was subsequently identified in the parish book of St. Helens, Adingdon, Berkshire, England. Osmund, a successful farmer and sheep owner, was recorded marrying Margaret Pulker on 12 May 1586. There is no controversy with this family as I find no listings in prior records transcribed, but soon discovered that Abingdon Parish is the only parish in Berkshire that has retained its own church books and therefore not available in the digital world.

Examination of the parish church book of St. Helen's Parish in Abingdon, Berkshire, England in 2016 resulted in the following relevant information to the ancestry of Sarah Jones Belknap:

12 May 1586 Osmond Garford & Margaret Pulcar were married.

28 January 1593 Margaret, daughter of Osmund Garford was baptized.

Probate Records (Wills and Administration) confirmed relationships to both Osmund Garford and Margaret Pulcar for several generations. The more significant will included the following:

- 1) Transcript of the Will of Osmond Pulker of Northcote, and translation of the Grant of Probate, dated 5 May 1557 and names mother Margaret Braie (Bray) of Shipton (Shippon), son John and mother Alice. Daughter Christia, Agnes, servant Osmund Dickson...written 12th day of the month of June in 1557.
- 2) Administration of John Pulcher of the Parish of St. Helen, Abingdon

Of John [sic] Pulcher of the Parish of St Helen, Abingdon

On the 11th day of the month of June in the year of our Lord 1600, the same venerable man Henry Marten, Doctor of Laws, the aforesaid Official; entrusted Letters of Administration for all and singular the goods, debts or credits of the said John Pulcher, deceased, to Marian Pulcher, his relict... and Stephen Pulker.

3) Transcript of the Will of Marian Pulcher of Northcote, and translation of the Grant of Probate, 1615 and 1616

She made her daughters Margaret Pulcher Garford and Joane Field, her whole executors.

There are numerous additional probate documents dating back to the mid to late 14th and 15th century connecting these families. The Garford, Pulker, Brae and Drews were significant land holders in Sutton Courtney and Sutton Wick and Draycott, all near the medieval abbey of Abingdon. For generations these families held freeholds of land with large sheep herds. Further research is ongoing and I am hopeful to extend this pedigree into the mid 1400s.


Pedigree of Margaret Garford, mother of Sarah Jones Belknap
