

# **PREFACE**

Volume X of The Settlers of the Beekman Patent continues the family histories of the 18<sup>th</sup> century residents of the Patent and adjacent Oblong. To be included in this series the surname had to appear on a Beekman or Pawling tax list, or served in a local military unit, or bought/sold or leased real property, or was recorded in a church or legal record as living in the Patent. Surnames in Beekman before 1790 are eligible for inclusion but we try to follow families to at least 1810 and frequently beyond. This volume continues our practice of incorporating in our Other and Unplaced probate for the nearby areas of the state of New York for the surnames in the Beekman Patent, usually up to about 1840. This information is now available to members of the New England Historic Genealogical Society at their website; www.NewEnglandAncestors.org, and we may not continue its inclusion in future volumes of this series.

With this volume we continue our collaborative publication effort with the New England Historic Genealogical Society of Boston, Massachusetts. (See announcement in their publication *New England Ancestors*, Spring 2003, vol. 4, no. 2, page 7). In addition to co-publishing we are able to announce that the NEHGS is making the individual chapters in the volumes available on their website to members of the society. Volumes I - IV are now on the site and family chapters are being added on an almost weekly basis. It is the intent of the writer and the society that NEHGS will complete the series in the event I am unable to do so for any reason.

Names in ALL CAPS in Other and Unplaced represent persons who were in Dutchess County before 1800, even if not the Beekman Patent.

This book contains 22 pages of additions and corrections (begins page 972) to the first eight volumes. We want to thank all who submitted this information and encourage others to send in any material they may have that would add to or correct what we have compiled. As noted many times, early New York State records are hard to come by. There are 62 surnames covered in this volume and the index contains over 32,000 entries. See pages 994-1003 for acronyms used in this work.

We repeat the apology from previous volumes to those whose family name is near the end of the alphabet and are many years in the future. The compiler is the only one involved in this project from research to indexing and will try to meet our self-imposed schedule of a volume every two years. The remaining scope of this series follows.

# THE RICHMOND FAMILY

The **Richmond family**<sup>1</sup> came to the Beekman Patent about the middle of the 18<sup>th</sup> century. The emigrant ancestor was John Richmond who was born ca. 1594 and came to the colonies from Ashton Keynes, Wiltshire, England about 1635. He was a purchaser of land at Taunton, MA in 1637. He lived several places in New England but returned to Taunton where he died 20 March 1664 aged 70. Several websites claim his wife was **Elizabeth**, b. ca. 1596, dau. of Richard and Jane (St. John) **Nicholas**.<sup>2</sup>

Also mentioned three children of dau. Elizabeth Hull; Sarah, Tristram and Hannah Hull.

She d. 26 April 1733 and he m. 2<sup>nd</sup> 27 March 1734, **Phebe Mott**. He came to the Beekman Patent by Feb. 1753 and his farm was assessed at £2.

Cyrus Richmond, brother of John of Westerly, RI was in Swago, Dutchess Co., NY 27 April 1753. His son Sylvester Richmond was noted as of Swago on the same date. He was mentioned in a road description of 15 Oct. 1759 in the Clapp Hill area. No record of death or burial.

they had visited Allen Moore<sup>8</sup> according to the request of Last Monthly Meeting: & the matted relating thereto being taken into solid consideration, it is the sense and judgment of this meeting that he ought speedily to be disowned; and Dobson Wheeler & Zebulon Ferris are appointed to Draw a Testimony against him and produce it to next meeting." The minutes of the Nine Partners meeting for 18<sup>th</sup> 11<sup>th</sup> month 1762 include: At this meeting a testimony against Abigail Richmond was produced & sign'd and Lott Tripp and Joseph Waters are appointed to see that it is read at Oswego and Joshua Haight at Nine Partners and John Wing at the Oblong and produce the original to the next monthly meeting." The minutes of the next monthly meeting reported that those appointed to read the testimony against Abigail Richmond had failed to do so and were ordered to read it at the next monthly meetings. 9 She was dismissed from the Nine Partners Friend's Meeting by the testimony.

He was a sawyer and is also listed as a private in Col. DeLancey's Corps and settled at Adolphustown, Upper Canada. 10

- 4. SYLVESTER<sup>5</sup> RICHMOND, (Cyrus<sup>4</sup>, John<sup>3</sup>, Edward<sup>2</sup>, John<sup>1</sup>), was born 4 June 1737 at Stonington, CT and came to Beekman by 1753 with his father. He was not taxed until 1770, about the time he was married. He was listed in the Quaker enrollment of 1755 as living Oswego, Beekman Patent. He married, probably in Oswego, Jane, born 5 April 1750, the dau. of Ichabod and Lydia (Mott) Bowerman who were living in Verbank, present town of Union Vale, DC. Sylvester Richmond is mentioned in the minutes of the Oblong Meeting held 20<sup>th</sup> 11<sup>th</sup> month 1763: "Samuel Dorland reported that he & Zebulon Hoxie had visited David Irish on account of his fighting Silvester Richmond, drinking to access (*sic*) & abusive language & conduct to Jonathan Hoag, & that they received no satisfaction...." Sylvestor Richmond was tried on an unknown charge in the Dutchess County Court of General Sessions 20 Oct. 1761 and was

discharged after paying fees. He was a customer at the Schenck store in the present village of Pleasant Valley, DC. On 31 Dec. 1764 he purchased sundries and on 3 Feb. 1765 he paid his account in full with cash of 4 shillings 10 pence. He purchased buttons, a skein of silk, 2 skeins thread, one pair garters, needles and 2 lbs. sugar. 12

Sylvester Richmond was taxed in Beekman from 1770-72 with an assessment of £1 in June 1770. He refused to sign the <u>AofA</u> in Beekman in 1775 but a Sylvester Richmond served in the Levies under Col. Marinus Willet. A Sylvester Richmond received Land Bounty Warrants for service in the 9<sup>th</sup> regiment of the Albany County, NY militia. <sup>13</sup>

He took a lease on property in lot 16 near his father-in-law, as noted in the following: "Sylvester Richmond, lot 16. (from folio 'B' 102). Lease bears date 1<sup>st</sup> of May 1769. The lives therein are the said Richmond, Cyrus Richmond Jr. his brother and Stephen Bull. The yearly rental is twelve bushels of wheat, one couple of hens & 1 days riding. The farm contains 101 acres. Rent to commence 1 year after lease date." 14

"Elijah Young has bought this farm for £50- he making application for an addition of Land and I have agreed to let him get 50 acres surveyed off contiguous to the other farm and to have a lease for the whole. For this acquisition he is to pay 6 bushels of wheat yearly and the new piece of land is to be 3 years rent free. He is to pay £5 for the privilege of purchasing."  $^{15}$ 

Sylvester Richmond was charged by the Grand Jury in 1763 that "sometime last spring with a large club or stake [he] did abuse, knock down and evilly entreat Bartholomew Noxon Jr., one of the constables for said [Beekman] Precinct." Sylvester Richmond went to Ernestown, Frontenac Co., Canada about 1795. He spent his last years between Kingston and the Bay of Trinity (Quinte?) where he died June 1803/04.

**5. CYRUS**<sup>5</sup> **RICHMOND**, (Cyrus<sup>4</sup>, John<sup>3</sup>, Edward<sup>2</sup>, John<sup>1</sup>), was born in Westerly, RI May 1748 and came to Beekman with his father by 1753. He m. **Rachel**, b. 1757, dau. of Richard and Rachel (Emigh) **Vincent** of Beekman.

He was given an ear mark in Charlotte Precinct, DC 16 May 1774; "two slites in the end of the left ear and a halfpenny the underside of the right ear." The mark was later transferred to Joseph Wilson. He was a Path Master in Charlotte Precinct in 1783 and 1786. He evidently had been attending the Quaker Meeting in Hudson, NY and had a removal certificate from there to Nine Partners Meeting 24 Feb. 1797. He came to Beekman at this time and was noted on a map of lot 20 as being on the west side of Velie Road, south of Todd Hill Road. He had a farm of 185 acres, which was later tenanted by William Randal. A sale of land in this area to Daniel Dean 23 July 1804 mentioned Cyrus Richmond as the northern boundary to the Dean property. Dean property.

He was a Pathmaster in Beekman in 1797, and a Pound Keeper in 1798 and 1799. He was fairly wealthy and was taxed in Oct. 1799 in Beekman on a house, an outhouse and land worth \$3,000, plus personal property valued at \$209. He was listed in 1800 in Beekman at 3-3-1-0-1 and 2-0-2-0-1 between Daniel Dean and Daniel Lawson.<sup>21</sup>

The Oswego Meeting minutes note that Cyrus and Rachel Richmond and children David, Sylvester, Jemima and Margaret took a certificate to Coeymans Meeting 20 June 1804. They lived in Schoharie County, NY after they left this area. She was noted on 30 April 1831 in a list of heirs of Affey Vincent, her brother, as living in Rensselaer, Schoharie Co., NY.

Jemima Vincent, sister to Rachel Vincent Richmond, died 25 Dec. 1835 at town of Durham, Greene Co., NY. On 26 March 1836 Vincent Stillwell, her nephew, petitioned the Surrogate Court for Letters of Administration, in which he named many heirs and where they lived. Part of the petition reads: "Her sister Rachel Richmond, deceased, wife of Cyrus Richmond had children (residences unknown, except as noted): Joseph Richmond, Rachel, wife of Alexander Coventry; Katurah, wife of Wallace--; Mary, wife of Stephen Hunt of Broome, Schoharie Co.: Jemima, wife of --; Richard Richmond, David

Richmond, Sylvester Richmond, of Broom Schoharie Co.; and Margaret Richmond..."<sup>22</sup>

# OTHER AND UNPLACED RICHMONDS

Benjamin Richmond of Saratoga District, Albany Co., NY was one of many men who petitioned Gov Clinton 4 Sept. 1779 for a permit to take flour to Boston to procure salt.<sup>24</sup>

Cyrus Richmond, age 24, was on a muster roll of Company #2 in the Northumberland, Canada militia in 1828. Sylvester Richmond, age 27, was in company #8 of the same regiment.

Mehetable, wife of Cyrus Richmond, died 12 Sept. 1801, age 21 in Saratoga Co., NY. 25

Edward Richmond b. 1721, d. 3 Dec. 1806. His wife Elizabeth Powell b. 1726, d. 18 Dec 1801. They are buried at Schoolhouse Rd. Cemetery, Austerlitz, Columbia Co., NY. Edward served as a Pvt., 9<sup>th</sup> Regiment, Albany Co. Militia according to Roberts, NYR.

Elizabeth Richmond and Peter Ben bp. son George Ben 10 Feb. 1788 at Kinderhook Reformed Church, Kinderhook, Columbia Co., NY.

Rev. James C. Richmond of St. Paul's Church, Poughkeepsie, was murdered 20 July 1866 by Richard Lewis. <sup>26</sup>

Josiah Richmond, b. 1760, d. 4 Jul 1826. His wife Mary \_\_\_\_, b. 16 April 1766 d. 15 Jan 1844. They are buried at Rogers Plot, Chatham, Columbia Co., NY. Josiah served as Pvt., 1<sup>st</sup> Reg. NY Line; Pvt., Malcolm's Levies according to Roberts, NYR.

Simeon Richmond, b. 2(2) Feb. 1758, d. 2(4) June 1827. His 1<sup>st</sup> wife Mary Walker, b. 1766, d. 9 Jun 1822. His 2<sup>nd</sup> wife Polly Fielding (not buried same cemetery). Simeon is buried at Chatham Union Cemetery, Shaker Museum Rd, Chatham, Columbia Co., NY. Simeon served as Pvt in Sgt VanAlstyn's (7<sup>th</sup>) Reg; Albany Co. Militia according to Fernow, NY Archives.

Sylvanus Richmond d. 21 March 1814, age 45 in Hudson, NY. His wife Rachel d. 29 July 1851, age 78 and they are buried in the Hudson City Cemetery, Columbia Co., NY. 27

THE RICKETSON FAMILY

The **Ricketsons** were early settlers in the Dutchess County and the Beekman Patent. The emigrant ancestor of this family is **William Ricketson** who married 14 May 1679 **Elizabeth**, born 6 Aug. 1659, dau. of Adam and Mary (Lott) **Mott**. He was English and a Quaker and settled first at Portsmouth, RI but soon left there for Dartmouth, MA. He was a carpenter and died 1 March 1691. His will is dated 29<sup>th</sup> 12<sup>th</sup> month 1691 and the inventory of his estate was produced 31 May 1707 and amounted to £367/17/0. His widow married 2<sup>nd</sup> to Mathew Wing 4 Sept. 1696.<sup>1</sup>
