castle and the shrievalty of Rokesburgh, he is now informed that he and his ministers have perpetrated divers oppressions of the people of those parts as well as damage in the castle, by colour of his office, and that he has not retained the number of men in the munition of the castle required by the indenture made between him and the king and that in place of men at arms and archers which by such indenture he should have had he has put there grooms, Scots and others, unfit persons and has borne himself ill in taking victuals without payment and beating men himself and by his ministers and perpetrating other misdeeds; and appointing them to make inquisition by the oath of good men of those parts and certify the king of the whole truth touching the premises.

Mandate to all mayors, sheriffs, ministers, bailiffs and others to Westminster, arrest and bring before the council all persons prosecuting appeals in derogation of the judgment of the justices of the Bench in a plea between Thomas son of Ralph de Asteleye and Master Adam Wykkemere, warden of the house of scholars of the Holy Trinity, Cantebrigge, by writ of quare impedit, touching the church of Brynyngham, that Adam should go without day and that Thomas should take nothing by his writ, to have the king's right brought to another judgement without the realm.
