John Chidiok, 'chivaler,' John atte Hale, 'chivaler,' Master John Corf and John Brunyng, during pleasure, to dispose of the issues thereof, beyond sustenance of the abbess, nuns, and a moderate number of servants, towards the succour of the abbey, stopping all corrodies, farms and other charges until the abbey be relieved, and expelling all suspected persons dwelling there; and granted protection with clause *nolumus* for the abbey. May 10. Pardon to John son of Geoffrey Harry of Walys of the king's suit  
Westminster. for the death of John Walshe; as the king has learned by the record of Robert Bealknapp and John de Whitewell, justices appointed to deliver the gaol of St. Albans, that he killed him in self-defence.

May 18. The like to William Helewys of Sytheston, for the death of Nicholas  
Westminster. Webster; on a like record of Thomas de Ingelby and his fellows, justices appointed to deliver the gaol of Leycestre.

May 16. Grant in frankalmoin to the prioress and sisters of the house of  
Westminster. the order of the Preachers, Derteford, of the manor of Portebrigg and all the lands, rents and services in Derteford, Wylmynton and Stone, and the advowson of the chapel or chantry of St. Edmund the King in the town of Derteford, which the king lately had of the gift of John de Bykenore of Claveryng, kinsman and heir of Robert de Bykenore of Derteford. May 18. Pardon, for 2 marks paid to the king by Roger Apeltweit, to him  
Westminster. for acquiring an estate in fee in a moiety of a messuage and of 30 acres of land in Haghele, held in chief, from William Goneware, who acquired the same from Robert de Ufford, earl of Suffolk, and entering therein without licence, as William had also done; and grant that he shall have the land again.

May 6. Writ of aid on behalf of Richard de Ayneshargh, mayor of Lyver-  
Westminster. pull, co. Lancaster, whom William Strete, chief butler, has appointed, during his pleasure, to be his deputy to take the prise of wines in the port of Lyverpull and levy the 2s. of each tun of wine due to the king in the said port, as also to receive any sums of money taken by other persons for the same causes in former times.
