May 16. Commission to Geoffrey Colepepir, sheriff of Kent, William Hare-Westminster. well and Roger Asshbournham, on information that the highway leading from the town of Penshurst in that county to Barden is deep and muddy, worn down by the frequent passing of carts and horses, to find who are bound and ought to repair the same and compel them to do so.

Commission to William de Acton, on information that many merchants and others passing with ships and boats by the water of Tyne to Newcastle-upon-Tyne throw ballast (lastagium) and other filth out of their ships and boats whereby the water is obstructed and the passage of ships and boats to the town prevented, and that goods and wares liable to custom are taken to foreign parts by the said water without payment of the customs and subsidies due to the king, to ordain by the best ways and means he can that such ballast and filth be not thrown into the water, to enquire by the oath of good men of the county of Northumberland touching goods and wares exported without payment of the custom due and what damage the king has sustained by this, and to certify the king from time to time of all that he does in this behalf.

May 17. Commission of oyer and terminer to Roger de Kirketon, Thomas de Westminster. Holbech, 'chivaler,' John de Wyke, John Hode and John Hawe, on complaint by Thomas de Dryby that Roger Cokar of Quappelade, William, his brother, Henry Thurlowe of Quappelade, William Wyot of Quappelade, Nicholas de Steynton of Spaldyng, William Broune of Multon and others, at Quappelade, co. Lincoln, assaulted him, carried away his goods and assaulted his men and servants.

May 15. Commission to William de Aldburgh, Henry de Barton, clerk, Westminster. Roger de Fulthorp, Ellis de Thoresby, John de Mitferd and John de Halydene, to make a perambulation between the land of Henry de Percy in Corbrigg, co. Northumberland, and the lands of the prior and convent of Hextildesham in Aynewyk within the liberty of Hextildesham; as the king is given to understand that there have often been quarrels and dissensions between them over the metes and bounds of these lands.
