- July 8. Commission of oyer and terminer to William de Fyncheden, Westminster. Thomas de Ingelby, Roger de Walsham, Roger de Fulthorp, John de Harleston, Robert de Morton and Thomas de Pynchebek, on complaint by the king's son Edmund, earl of Cambridge, that certain evildoers broke his parks and closes at Haytfeld, Thorne, Fisshelak, Steynford, Connesburgh, Wakefeld, Sandall, Horbury, Stanlay, Osset, Soureby, Hiperom, Halifax, Warlullay, Miggelay, Waddesworth, Stanfeld, Langefeld and Risssheworth, co. York, entered his free chaces and warrens, hunted in the parks, chases and warrens without licence, felled trees there, fished in his several fisheries, took away fish, trees and other good there and at Staunford and Grantham, co. Lincoln, deer from the parks and chaces, and hares, conies, pheasants and partridges from the warrens, and assaulted his men and servants.
- July 10. Association of Thomas atte Ook of Bergham in the commission of Westminster. the peace and of oyer and terminer in the county of Essex to Hugh de Badwe, Robert Bealknap, John de Cavendissh, Henry de Coggeshale, John de Sudbury, John atte Welde, Humphrey de Bohun, late earl of Hereford and Essex, and Thomas de Lodelowe, the last two being dead; with proviso that the other commissioners are not to await his presence before proceeding to business.
- July 10. Commission to Robert Hertele, Adam Caperon and Robert Bungeye Westminster. to follow and arrest John Budene of the county of Berks, Thomas Hare of Kentbury of the county of Berks, John Stykepak of Farndon, co. Berks, Adam Baily of Sottone by the mill of Sottone, co. Berks, John Ravenser, 'bocher,' of Boreford of the county of Oxford, William Bakere of Boreford, co. Oxford, Adam Smyth of Godestowe, co. Oxford, Hugh Cartere of Thame of the county of Oxford, John Kent, 'hostiler,' of Deppeford, co. Cambridge, and John atte Cruche of Thame, co. Oxford, who are appealed by Richard de Southpedirton of the county of Somerset, the king's approver detained in Wyndesore gaol, before Richard de Abyndon, one of the coroners of the county of Berks, of divers felonies committed with him, as the king is informed that they are vagabond in divers parts of the realm; and to bring them to the said gaol for safe keeping until they be delivered according to law and the custom of the realm.
