Westminster. Richard, parson of the church of Flevorth, for not appearing before the justices of the Bench to answer John Bannebury, merchant of Gloucestre, touching a debt of 32*l.* 11*s.* 8*d.* Gloucester.

Westminster. John Ludeseye of Burnham, for not appearing to answer John Grene of Burnham touching a debt of 12 marks. London.
