Hamas stuck in the middle after attacks

GAZA CITY, Gaza Strip A new round of violence between Israel and Palestinian militants has Gaza's Hamas rulers caught between reluctance to take on Israel and discomfort with reining in fellow Islamists from smaller, more radical groups involved in the fighting.

The fighting has killed 10 Palestinians and an Israeli, casting doubts on assessments that the recent prisoner swap between Israel and Hamas might improve relations.

Despite the worst bloodshed in months, both sides indicated they were interested in restoring calm in the bitter dispute.

Hamas, which has ruled Gaza since 2007, has avoided direct involvement in the latest burst of fighting. Hamas lost hundreds of men in a fierce Israeli offensive three years ago and has largely maintained calm since then. At the same time, the

group, which has killed hundreds of Israelis, remains committed to armed struggle against Israel.
